
Background

The Corn Exchange has proved to be a popular venue and focal point for the town and community providing exciting, diverse and vibrant events that have increased in numbers over the past 18 months.


It now hosts a variety of events throughout the year ranging from theatre and comedy to music and lectures. The Venue and Events Officer and the Venue and Events Assistant are currently working on upcoming events in the Corn Exchange over the Autumn and Winter period. These events will run alongside any additional third-party bookings ensuring there is a varied range of different events to look forward.

Current Situation

To demonstrate the usage of the main hall the chart below details the most common categories of events held this year including the total income received.



The following table provides further detail of the events held noting the top line was a charity event and not income received by the Council.

Proposal for change to Group 4 hire charge.

Current status of Group 4 rates

Performance (weekday)

½ Day: £200.00Full Day: £400.00

Performance (weekend)

½ Day: £300.00Full Day £600.00

Technical/Dress Rehearsal (weekday)

½ Day: £150.00Full Day: £300.00

Technical/Dress Rehearsal (weekend)

½ Day: £200.00Full Day: £400.00

New Proposal

The new Group 4 proposed charge will remove the weekday and weekend charge variance and apply to any show where an audience is in attendance and being charged to attend:

- £300 for a half day (Minimum hire period)
- £600 for a full day

This charge will include use of all facilities including the bar at no additional cost.

For tech and dress rehearsals with no audience in the new Group 4 tech and dress charge will apply to any day of the week:

- £150 for a half day
- £300 for a full day

This does not include hire of the bar but does include all Main Hall facilities.

This proposed change will simplify the booking process and administration within the Council and help maximise the potential use of the bar and café.

The hire charges remain competitive as will be demonstrated in future reports in line with the review of rates charged.
