# Background



# **Recent events**

#### **England EURO 2024 Screenings**

Screenings of England's EURO 2024 matches on The Corn Exchange Cinema Screen were organised targeting local youth football clubs and families. Witney Vikings Football Club were fully engaged advertising directly to their members and publicly on social media and have shown their appreciation for WTC delivering these screenings.

Lots of people have attended The Corn Exchange for the first time due to these screenings, which will help our public awareness going forward.

Excellent social value for the town aligning with the purpose of the Corn Exchange and business plan. Officers have worked hard to ensure that these screenings are delivered to a high standard with improvements made to provide a higher quality picture. The hall contained England flags and a EURO's playlist was created for the bar pre-match to enhance the exciting atmosphere.

#### **University of Gloucestershire Student Project**

This project has been completed, with some impressive work submitted by both groups of students. Some of this work, including design and event programming ideas will be considered for use by officers. An invite to attend a council meeting to present their work has not been taken up, but may be an option when they return to university for their final year in September.

#### Weddings

The Corn Exchange hosted another beautiful wedding reception on Saturday 29<sup>th</sup> June with a busy evening behind the bar, (£2,500 in bar takings).

Officers have been working alongside Bride & Beautiful events to promote a Wedding Fair at The Corn Exchange on 31<sup>st</sup> August. 50% of stall holders are booked already and the event will make use of the Main Hall, Gallery Room and 1863 Café & Bar. Revenue streams for this event is via stall holder fees and café & bar sales.

# **Live Music Outdoors**

As covered in the last report, officers are organising music for outside The Corn Exchange for Fridays on evenings where this can move inside if the weather is bad. This is to avoid late cancellations and loss of revenue where cancellation fees could be owed to the artist, as well as preventing a bad reputation for cancelling with late notice. The first dates will be 12<sup>th</sup> July and 26<sup>th</sup> July, and acts are being finalised this week.

Smarts fish and chips have agreed to equally share the cost of the live performer (£150) and to co-advertise.

#### **Golden Era Show**

The Corn Exchange has a live music show coming up on 19<sup>th</sup> July with Justin Daish (founder of the popular Shadowing Hank show from last November). Ticket sales have been slower than we hoped at this stage, therefore, Officers will be increasing the focus on targeting the marketing of this show over the next couple of weeks. As mentioned, in previous reports, we are finding ticket sales are coming later than ever, creating an unpredictable environment for ticketed live events. This show is working on a ticket split with the artist.

#### Cinema

The classic film club took a forced hiatus due to the screenings of the EURO's, however attendance was starting to pick up. Officers had found that weighting the promotion closer to the date of the screening saw more success and higher attendance. Therefore, plans are in place to do this when the screenings start again.

In the meantime, a one-off special screening of Grease Sing-a-long addition is booked in for 12<sup>th</sup> July to coincide with Fizzy Friday and Live Music.

#### Autumn Events Program

The Autumn/Winter season is getting booked up and officers are looking forward to an increased number of live music, theatre shows, and private functions booked in.

# **Environmental impact**
