The purpose of this report is to enable the Council to elect representatives to vacancies on its Committees and to external organisations.

# **Background**

Committee membership is usually reviewed at the Annual Meeting of the Council in May but vacancies can arise throughout the year and may be filled by the Committee or at Full Council.

The Town Council appoints representatives to External Organisations and Outside Bodies, and it is usually recommended that those appointed should serve until the Annual Council Meeting following the next ordinary election of Councillors in 2027.

Due to the constitutions and arrangements of certain bodies, along with resignations, requests periodically arise throughout the year for the Council to consider.

# VE & VJ Day 80<sup>th</sup> Anniversary Working Party/Task & Finish Group

At the Stronger Communities Committee meeting held on 23 September 2024, it was agreed this group should be formed to formulate plans for the 80<sup>th</sup> anniversary of VE & VJ Days, which fall on 8 May and 15 August 2025 respectively (minute no. SC523(4) refers).

A minimum of **5 Members** are required for the membership.

#### External Organisations & Outside Body Nominees - Serving as Trustees

### Witney Educational Foundation (WEF) – 4-year term of office

WEF provides financial support for the schools of Witney and surrounding communities to enable all students to enjoy full range of activities offered by each school. It also provides grants for families in need, to assist with the cost of extra-curricular activities, educational visits, school clothing and other essential items

The former central ward member was elected to this position which 1 vacancy.

The departure of the above Councillor also leaves vacancies as a Town Council **Home Start Champion** and on its **Youth Council Task & Finish Group**. In addition, the former Central Ward Member was appointed as the Town Council's representative on the **Witney Community Insight Profile Steering Group**. Work on this project is well underway and the Council is asked whether it would like to select a new representative.
