<u>Apollos</u>

Apollos Clothing is a Witney based charity focused on eliminating clothing poverty and reducing textile waste. They collect and refurbish preloved and outgrown clothes to provide clean, quality garments to families in need, especially through referral partnerships with schools, refuges, food banks, and social services. Their volunteer Sewing Squad upcycles garments fixing minor defects, so items avoid landfill. This ethos blends dignity, environmental care, waste reduction, and community empowerment.

Witney & West Oxfordshire Food Bank

Witney & West Oxfordshire Foodbank is a volunteer-run charity that believes no one in the community should go hungry. Operating as part of the Trussell Trust network, it provides nutritionally balanced emergency food parcels (typically a minimum of three to five days' worth) and essential toiletry items to people in crisis—referred by frontline professionals such as GPs, social workers, schools, and Citizens Advice. Rooted in compassion and partnership, it offers practical support alongside a warm, non-judgmental welcome.
