Agenda Item: Annual Resident's Survey 2025

The purpose of this report is to present Members with the results of the annual residents' satisfaction survey, conducted between February and May, regarding services overseen by this Committee and external authorities/organisations.

Background

The survey was sent to every household in the post and was promoted online via social media and in the local secondary schools; 344 responses were received in total.

While the number of responses is a very small percentage of the population, the results are still an important resource in advising the Council in which areas projects, communications, and future spending should be considered.

Current Situation

All Council Standing Committees have received reports outlining the scores and comments for services under their remit during the current meeting cycle.

As the Committee with overall financial and policy-making powers, the remainder of the comments include general comments about the town council, its services and those relating to other organisations. These can be seen below:

We moved to Witney 10 years ago from Oxford. Best thing we ever did.

Mobility problems make use of services difficult.

Some areas need some more work

Overall, good service. Thank you.

The cost of your services is horrendous - 66% higher than Banbury town. It would appear a lot of this is waste, such as the losses at the Corn Exchange bar - how much does that cost exactly, I don't see a figure on the leaflet? Are we really to believe that the Corn Exchange now costs us each 25p LESS than it did three years ago? That sounds hopelessly optimistic to me.My other big concern is the vast expense of your empire building. The cost of "Corporate Management" has risen by a staggering 77% over the last three years - SEVEN times the CPI rate of inflation. Despite the huge increase in council tax - 28% in the last three years - the quality of services is no better. The town is run down & tatty & when you do get round to cutting the grass, it would appear that none of your staff have a broom, so the clippings are left in great mounds on the weed-infested footpaths. "Capital Projects" are costing us each £17.72 this year, but there is no explanation of what they are. Are we not allowed to know? At a time when costs are going through the roof, income from "Leased Community Halls" has been consistently going down. Perhaps it's time to find new tenants or repurpose these assets to give us better value? I would appreciate more-honest communication about what our taxes are actually being spent on, even if that means a whole page of boring itemised accounts in the leaflet in place of the vague, nebulous nonsense you currently publish.

Assistance from town councillors even for issues outside direct control and responsibility has been excellent in the past couple of years and the improved accessibility of councillors and communication methods are exemplary. Such a shame the same cannot be said of the District and particularly the County Council.

Stop spending money on vanity projects, listen to residents and reopen the High St.!

As you can see, I don't use any of the services that the town council are responsible for. So I'm REALLY not happy that the council tax goes up (multiple times) quicker than working people's wages. Can only be squeezed so much, until something gives out!

Overall I think you are doing a good job but You are spending huge amounts of money on services which should be provided by other council - what do you get in return?

The arguing and back biting from councillors around here is just pathetic and makes me not want to bother voting. Just do what's best for Witney and us!

Seems to me the TC (i.e. the management and staff thereof) do take pride in doing the best possible with finite resources for infinite insatiable demand!

Better bigger leisure centre. and more stuff to do like a trampoline park or soft play centre We need better, free, toilet facilities in public places. We need better sports facilities for all ages.

Lower rates on shops to have more choices - please NO MORE CAFES OR CHARITY SHOPS + especially no barbers

Litter is a big problem in Witney - this town is so lovely! We need a public campaign to stop it now.

I like the displays on Marriotts Walk e.g. Umbrellas + butterflies. Thank you :)

Lacking ladies & gents outfitters now

I believe the streets of Witney town and close to could be cleaner, regular litter picking, more bins along Welch Way, and larger ones around the town.

Could be more bins e.g. by the benches on High Street. Find High St. easier to cross with less traffic as I am somewhat disabled.

The Markets in Marriotts Walk were good. I feel we need a few more Dog Poo bins, have seen poo bags left on the street.

I feel more could be made of Marriot's Walk. Need to attract businesses into empty lots. Maybe create more of a cafe culture with outdoor seating around the cinema end of the place. Witney is crying out for a good quality wine bar and needs better restaurants if we are to stop the decline in Witney's status. I look forward to the high street makeover but feel cars should be allowed down there to ease traffic on Witan Way!

Not sure who is responsible for the upkeep of Witney buildings, but many of the properties in the High Street are badly in need of maintenance. Perhaps landlords should be called to account. There is no point in having flower troughs and seating with buildings falling apart.

Please could you consider making more recycling bins available rather than everything being in one bin

Make tidying up the town centre a priority, it's a WODC responsibility so get some money from them as they are not doing it

We need more police patrols. Less potholes.

What about the potholes in the roads around Witney and the surrounding villages

Potholes particularly through church

Overgrown footpaths, notified on fix my street, email case closed, no action. Church green benches need attention! Footpaths and hedges need more attention, grass cutting on grass verges not often enough.

Poorly maintained paths in Witney

There are plenty of routes to walk into Witney from Madley - however, none are really pushchair friendly as pure mud baths. So would like more accessible routes. Traffic can be a nightmare along the Woodstock road and Witan Way so tend to avoid going to Witney on a weekend to avoid traffic which doesn't help support local businesses

Lots of areas in Witney need cleaning and tidying properly, roads including A40 are not maintained well, traveller response and tidying needs following up, communication is poor, no need to put cameras on the high street, street and road signs are broken and not maintained properly, rubbish on A40 on route into Cotswolds and POTHOLES! Thank you.

The town is dirty and unkempt. Benches covered in bird poo. Weeds not removed from pavements. Embarrassing when friends visit. Woodford way all the way past the Windrush health centre!

Lobby OCC to hoover the drains, they ignore them and this leads to greater problems across the town

Better roads

Better safe crossings for school children around schools and in general better maintenance Poor walking areas I.e. to get from Cogges to Witney country park you need to walk through fields which means they are not very accessible or walk along busy Witan way. Paths could be installed for all year-round use. In addition, there isn't many walking spots in the town despite lots of countryside, for example Tar lakes is lovely but that pathed area is tiny. Also, the path between Cogges and town (2 bridges) is dark at night and as a woman walking to town each evening to the leisure centre, it can feel unsafe in winter months, a bit more lightning would make it a safer route!

More police funding desperately needed. It's been over 30 years since under section 74 of the British highways act and 1985 of the Scottish highways act. It's been illegal for any one over the age of 10 to ride a bike on pedestrian footpaths in the UK. This law is not being enforced. Making footpaths dangerous for pedestrians

If this law was enforced the money generated from fines. Could go back into public spending. £60+ on the spot for Breaking the law. £500 for dangerous or re-peat Offenders. Hundreds Could be raised every day. Making footpaths safe for pedestrians

It is also Appalling that there is on signage any where in town Emphasizing this law

There also needs to be more funding for mental health services.

Concerns of anti-social behaviour around Deer Park Field and Town Centre - E-scooters, smoking weed, damage to Playgrounds.

There is inconsistency in the maintenance of the areas under control. Some spaces are spoiled by alcohol and drug users litter. Some spaces become inaccessible.

Other – Woolgate Centre

A bench outside the main Waitrose entrance is needed. There used to be one there!

Impact Assessments

The Town Council has a duty to consider the effects of its decisions, functions and activities on equality, biodiversity, and crime & disorder. Consideration should also be given to effects on the environment, given the Council's Climate Emergency declaration in 2019.

- a) Equality The residents' survey helps identify service inequalities and amplify underrepresented voices, supporting fairer, more inclusive decision-making. It may also highlight items which need addressing under the Equality Act 2010.
- b) Biodiversity The Council must ensure any issues are dealt with in line with biodiversity legislation and its own policy.
- c) Crime & Disorder The survey provides the ability to highlight concerns about safety and anti-social behaviour. The survey can inform targeted responses, resource allocation, and partnership working with police and community safety teams. It may help identify hotspots, vulnerable groups, and areas needing intervention such as the cemeteries.
- d) Environment & Climate Emergency The survey supports the Council's climate emergency commitments by ensuring resident feedback can help shape relevant policies and actions.

Risk

In decision making Councillors should give consideration to any risks to the Council and any action it can take to limit or negate its liability.

There is a reputational risk if the Council does not address comments received in its satisfaction survey as it will be seen as not listening to residents.

The Council's committees will have competing demands on the overall Council budget so any additional project funding has to be balanced and proportionate. Additions should be in line with Councils objectives and adopted policies/strategies.

Social Value

Social value is the positive change the Council creates in the local community within which it operates.

Listening to residents' feedback on Council services delivers significant social value by showing empowerment, inclusion, trust, and community wellbeing; It affirms that their opinions matter and helps building a sense of respect and transparency. This is especially important for the Council, where inclusive decision-making ensures diverse needs are reflected in service design and delivery.

Internally, it supports continuous improvement across the Council's services and helps identify future objectives thereby demonstrating meaningful change.
