

**OXFORDSHIRE COUNTY COUNCIL
(WITNEY AREA) (SPEED LIMITS) ORDER 20****

The Oxfordshire County Council, in exercise of its powers under Section 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Witney Area) (Speed Limits) Order 20** and shall come into force on the day of . 20**.
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour in any of the lengths of road specified in Schedule 1 to this Order.
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour in any of the lengths of road specified in Schedule 2 to this Order.
4. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour in any of the lengths of road specified in Schedule 3 to this Order.
5. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour in any of the lengths of road specified in Schedule 4 to this Order.
6. No speed limit imposed by this Order applies to a vehicle falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011, being a vehicle used for naval, military or air force purposes, when used in accordance with regulation 3(5) of those regulations.
7. The Oxfordshire County Council (Witney Area) (Speed Limits) Order 2020 is hereby revoked/replaced.

SCHEDULE 1

20mph speed limit:

PART A (Cogges Area)

a)	Church Lane	for its entire length
b)	Meadow View	for its entire length
c)	Stanton Harcourt Road	for its entire length

PART B (Northeast Area)

The whole length of every road in the area bounded by the A4095 Woodstock Road & Jubilee Way in northeast Witney, extending out to the following points:

a)	Harvest Way (Northern end)	its junction with the A4095 Woodstock Road
b)	Harvest Way (Southern end)	its junction with Jubilee Way
c)	Madley Way	its junction with Jubilee Way
d)	Waterford Road	its junction with Jubilee Way

PART C (Town Centre)

The whole length of every road in the area bounded by the A415 Ducklington Lane, Welch Way & Witan Way in central Witney, extending out to the following points:

a)	Corn Street (Western end)	its junction with the A415 Ducklington Lane/A4095 Tower Hill
b)	Corn Street (Eastern end)	its junction with Witan Way
c)	Holloway Road	its junction with Welch Way
d)	High Street	its junction with Welch Way
e)	Station Lane (leading northwards from Witan Way)	its junction with Witan Way
f)	Welch Way	westwards to its junction with Woodford Way

SCHEDULE 1 2

30mph speed limit:

The whole length of every road in Witney (except those roads and sections of road listed in **Schedules 2 1 & 3**) extending, in the case of the respective roads leading out of the town, to the following points:

a)	A4095 Curbridge Road	125 metres southwest of its junction with Deer Park Road
b)	B4047 Burford Road	55 metres west of its junction with Tower Hill
c)	Crawley Road.	222 metres northwest of its junction with Quarry Road
d)	Hailey Road	222 metres northwest of its junction with Eastfield Road (partly in the parish of Hailey)
e)	New Yatt Road	182 metres northeast of its junction with Early Road
f)	Oxford Hill	50 metres southeast of its junction with Cogges Hill Road
g)	Stanton Harcourt Road	30 metres south of its junction with Manor Road

h)	Woodstock Road A4095	288 metres northeast of its junction with Harvest Way	
i)	Ducklington Lane, A415	A point 95 metres south of the A415/A40 Slip Road roundabout junction	
j)	Thorney Leys	to a point 89 metres west of its junction with Ducklington Lane.

k)	Downs Road	from its junction with the B4047 Burford Road, southwards	for a distance of 1040 metres.

40mph speed limit:

a)	Book Ends	for its entire length.	
b)	B4047 Burford Road	from a point 55 metres west of its junction with Tower Hill, westwards	to a point 411 metres west of its junction with Downs Road - partly in the Parish of Curbridge.
c)	Deer Park Road	for its entire length.	
d)	Range Road	for its entire length.	
e)	Thorney Leys	from a point 540 metres southeast of its junction with the A4095 Curbridge Road, eastwards	to a point 89 metres southwest of its junction with Ducklington Lane.
f)	A4095 Witney to Woodstock road	from a point 50 metres southwest of its junction with Park Road, North Leigh, north-eastwards	to a point 380 metres northeast of its junction with Park Road, North Leigh.
g)	A4095 Curbridge Road	from a point 125 metres southwest of its junction with Deer Park Road, south-westwards	for a distance of 250 metres.
h)	Downs Road	from a point 1040 metres south of its junction with the B4047 Burford Road, southwards	to its junction with Main Road (partly in the parish of Curbridge)
i)	Downs Road / A40 Link Roads	from their roundabout junction with Downs Road (including	to its roundabout junction

SCHEDULE 3

50mph speed limit:

The A4095 Witney to Woodstock road within the Parishes of Witney and North Leigh:		
A4095 Witney Road	a) from a point 288 metres northeast of its junction with Harvest Way, Witney (the terminal point of the existing 30mph limit), north-eastwards	to a point 50 metres southwest of its junction with Park Road, North Leigh
	b) from a point 380 metres northeast of its junction with Park Road, North Leigh, north-eastwards	to a point 117 metres northeast of its junction with Cuckoo Lane, North Leigh (the terminal point of the existing 40mph speed limit) a distance of approximately 4150 metres.
Jubilee Way, Witney	from its junction with Woodstock Road, Witney, southwards	to its junction with Oxford Hill, Witney, approximately 1650 metres.

The A40 Witney Bypass in the Parish of Witney:		
A40 dual carriageway	from a point 326 metres west of the centre of Downs Road overbridge, eastwards (including the roundabout circulatory lanes)	to a point 489 metres east of the centre of Downs Road overbridge.
